Philip Brown proposed developing duplexes in Coolidge for affordable housing, highlighting the need for 12-30 new residents. He estimated the economic impact at \$1.3-\$1.5 million and mentioned potential financing from Thomasville National Bank and South Georgia Banking Company. The duplexes would feature three bedrooms, two baths, and a one-car garage, priced around \$1,500 monthly. The city owns four lots on East Violet Street, suitable for four duplexes.
